ORDINANCE NO. 2016-772** AN ORDINANCE OF THE TOWN OF NORTH REDINGTON BEACH, FLORIDA, AMENDING SECTION 18-58 OF ARTICLE III OF CHAPTER 18 OF THE CODE OF ORDINANCES OF THE TOWN OF NORTH REDINGTON BEACH GOVERNING UTILITY TRAILERS ON CONSTRUCTION SITES DURING PERMITTED CONSTRUCTION AND PROVIDING FOR AN EFFECTIVE DATE.
