ORDINANCE NO. 2014-749** AN ORDINANCE OF THE TOWN OF NORTH REDINGTON BEACH, FLORIDA, AMENDING SECTION 74-123 OF ARTICLE III OF CHAPTER 74 OF THE CODE OF ORDINANCES OF THE TOWN OF NORTH REDINGTON BEACH AMENDING THE RESTRICTIONS ON THE SPEED OF BOATS OR SIMILAR INSTRUMENTALITIES IN TOWN WATERWAYS AND PROVIDING FOR AN EFFECTIVE DATE.
