PUBLIC HEARING ON TENTATIVE BUDGET AND PROPOSED MILLAGE RATE FOR FY 2022-2023.

PROPOSED MILLAGE RATE OF 1.0 IS 11.79% ABOVE THE ROLLED-BACK RATE OF .8945.

A. *ORDINANCE NO. 2022-851 AN ORDINANCE ADOPTING THE FINAL MILLAGE RATE FOR THE TOWN OF NORTH REDINGTON BEACH, FLORIDA, FOR THE FISCAL YEAR COMMENCING OCTOBER 1, 2022 AND ENDING SEPTEMBER 30, 2023, AT THE RATE OF 1.0 MILLS; PROVIDING FOR THE ADOPTION OF THE FINAL MILLAGE RATE; AND PROVIDING AN EFFECTIVE DATE. FIRST READING.*

B. *ORDINANCE NO. 2022-852 AN ORDINANCE ADOPTING A FINAL BUDGET FOR THE TOWN OF NORTH REDINGTON BEACH, FLORIDA, FOR THE FISCAL YEAR COMMENCING OCTOBER 1, 2022 AND ENDING SEPTEMBER 30, 2023, INCORPORATING BY REFERENCE SCHEDULES SETTING FORTH ESTIMATED ANTICIPATED EXPENDITURES AND ESTIMATED REVENUES; PROVIDING FOR AND APPROPRIATING FUNDS TO PAY OPERATING EXPENDITURES, CAPITAL EXPENDITURES, DEBTS, DEBT SERVICES AND MISCELLANEOUS EXPENDITURES; APPROPRIATING AND ALLOCATING FUNDS, REVENUES, SERVICE CHARGES, FINES AND FORFEITURES, TAXES, REVENUE-SHARING; LEVYING AD VALOREM TAXES SUBJECT TO TAXATION WITHIN THE TOWN; DIRECTING THAT AD VALOREM TAXES SHALL BE ASSESSED AND COLLECTED FOR THE CALENDAR YEAR 2022, PROVIDING FOR THE ADOPTION OF THE FINAL BUDGET; AND PROVIDING AN EFFECTIVE DATE. FIRST READING.*

C. *ANNOUNCEMENT: PUBLIC HEARING TO ADOPT THE FINAL MILLAGE AND BUDGET WILL BE AT THE TOWN HALL, 190 - 173RD AVENUE AT 5:05 P.M. ON FRIDAY, SEPTEMBER 16TH, 2022.*
