PROPOSED MILLAGE RATE OF 1.5 IS 45% ABOVE THE ROLLED-BACK RATE OF 1.0345

A. *ORDINANCE NO. 2025-874 AN ORDINANCE ADOPTING THE FINAL MILLAGE RATE FOR THE TOWN OF NORTH REDINGTON BEACH, FLORIDA, FOR THE FISCAL YEAR COMMENCING OCTOBER 1, 2025 AND ENDING SEPTEMBER 30, 2026, AT THE RATE OF 1.5 MILLS; PROVIDING FOR THE ADOPTION OF THE FINAL MILLAGE RATE; AND PROVIDING AN EFFECTIVE DATE. B. *ORDINANCE NO. 2024-875 AN ORDINANCE ADOPTING A FINAL BUDGET FOR THE TOWN OF NORTH REDINGTON BEACH, FLORIDA, FOR THE FISCAL YEAR COMMENCING OCTOBER 1, 2025 AND ENDING SEPTEMBER 30, 2026, INCORPORATING BY REFERENCE SCHEDULES SETTING FORTH ESTIMATED ANTICIPATED EXPENDITURES AND ESTIMATED REVENUES; PROVIDING FOR AND APPROPRIATING FUNDS TO PAY OPERATING EXPENDITURES, CAPITAL EXPENDITURES, DEBTS, DEBT SERVICES AND MISCELLANEOUS EXPENDITURES; APPROPRIATING AND ALLOCATING FUNDS, REVENUES, SERVICE CHARGES, FINES AND FORFEITURES, TAXES, REVENUE-SHARING; LEVYING AD VALOREM TAXES SUBJECT TO TAXATION WITHIN THE TOWN; DIRECTING THAT AD VALOREM TAXES SHALL BE ASSESSED AND COLLECTED FOR THE CALENDAR YEAR 2025, PROVIDING FOR THE ADOPTION OF THE FINAL BUDGET; AND PROVIDING AN EFFECTIVE DATE. SECOND AND FINAL READING.*

C. ORDINANCE NO. 2024-876 AN ORDINANCE OF THE TOWN OF NORTH REDINGTON BEACH, FLORIDA, AMENDING THE TOWN'S BUDGET FOR THE FISCAL YEAR 2024-2025 AND PROVIDING FOR AN EFFECTIVE DATE. SECOND AND FINAL READING.
