### **OLD BUSINESS**

ORDINANCE NO. 2025-869 AN ORDINANCE OF THE TOWN OF NORTH REDINGTON BEACH, FLORIDA, AMENDING SECTION 10-22 OF CHAPTER 10, ARTICLE II, DIVISION 4, OF THE CODE OF ORDINANCES CONCERNING THE MINIMUM AGE FOR EMPLOYMENT AT ADULT USE ESTABLISHMENTS; MAKING RELATED FINDINGS; PROVIDING FOR CODIFICATION, SEVERABILITY, AND FOR AN EFFECTIVE DATE. SECOND AND FINAL READING

SECOND AND FINAL READING.
